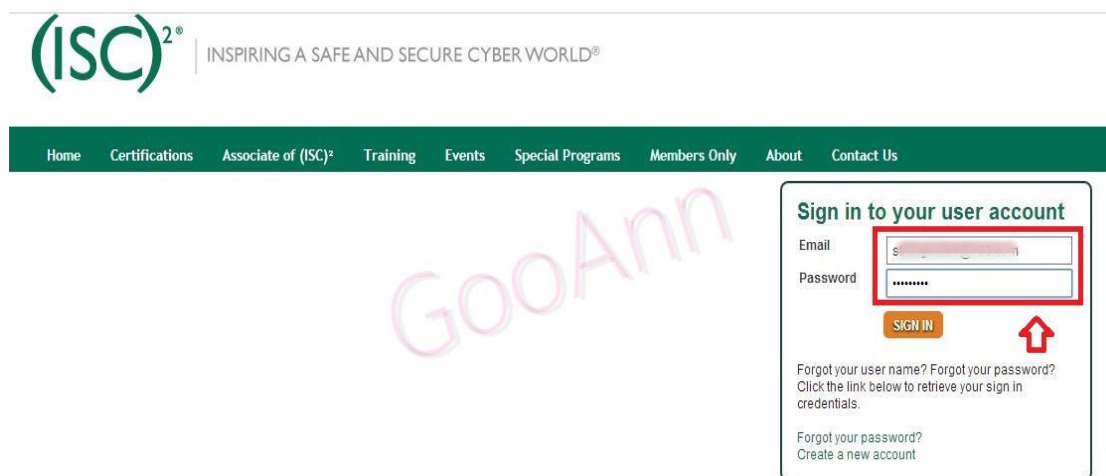

## 附：CISSP 持续教育（CPE）政策说明

CISSP CPE 政策要求在年度和三年认证期都达到 CPE 所要求的学时。

CISSP 必须符合如下要求才能保持其资格：

1. 每年最低应达到并报告 40 个 CPE 学时；
2. CISSP的CPE分A组和B组，A组是与8个CBK相关活动；B组是8个CBK领域之外的活动，B组不作为强制要求，但其提交CPE数量每年不应超过10个；  
( 参考 “CPE Type” )
3. 向 (ISC)2国际总部全额交付 证书维护年费85\$；
4. 在三年报告期间最低应达到并报告 120 个CPE 学时；
- 5、如证书申请工作经验不符合，可以先申请成为CISSP准成员，每年需支付35美金进行维持。
- 6、如维持费和CPE年内未缴纳或填报则证书作废。

## CPE积分范围

1. 厂商的培训：CISSP参加厂商举办的培训、讲座等，每小时可获得1个CPE；
2. 安全会议：CISSP参加安全会议，每小时可获得1个CPE；
3. 大学课程：CISSP参加大学课程学习并通过，每学期可以获得11.5个CPE；
4. 出版安全论文或书籍：CISSP可以通过出版安全书籍获得40个CPE，或出版安全文章获得10个CPE，以此种方式3年内最多获得40个CPE；
5. 提供安全培训：CISSP进行安全讲座、授课每小时可以获得4个CPE，以此种方式每年内最多获得80个CPE；



6. 服务于安全专业组织的管理层：CISSP每年可以通过服务获得10个CPE，但以此种方式最多可以获得20个CPE；
7. 自学：CISSP可以通过自学取得CPE，以此种方式3年内最多获得40个CPE；
8. 阅读安全书籍：CISSP可以通过阅读信息安全书籍的方式获得10个CPE，但每年只有一本书被承认；
9. 志愿工作：CISSP可以通过作为(ISC)2的志愿者的方式获取CPE，分数和具体的活动由(ISC)2决定；
10. 其他：若CISSP希望以其他的方式获得CPE，但必须提交给(ISC)2的再认证委员会批准。
